What is a levy?

A levy is a local property tax passed by voters of a district that generates revenue to fund programs and services that the state does not pay for as part of "basic education".



Is this levy a new tax?

No, this levy is not a new tax. This will replace a levy that is currently being collected. The current levy expires this year and this replacement levy will continue to fund essential student programs and services for the next three years.



How much is the district seeking and what would that mean for our property tax rates?

The district is asking for an estimated \$1.34 per \$1,000 of assessed value.

Reason Toledo is Asking for \$1.34

- Insurance costs increased by over \$100,000
- The state took away over \$430,000 of state local effort assistance (LEA) funds in 2023-2024
- Rising utility costs (the district is underfunded by the state in utilities by more than \$150,000 this year)


Potential Cuts if Levy Does Not Pass

Some Cost Savings Already Implemented for the 2023-2024 School Year

- Elementary Principal position vacated and assumed by LAP Director and Superintendent (savings roughly \$137,150)
- Additional Attrition Not hiring new positions when staff leave, e.g., two library positions, an office assistant, and an elementary P.E. teacher (savings roughly \$212,050)

PROPOSITION NO. 1

TOLEDO SCHOOL DISTRICT

REPLACEMENT EDUCATIONAL PROGRAMS AND OPERATIONS LEVY

The Board of Directors of Toledo School District adopted Resolution No. 2023-24-02 concerning a replacement levy for education. This proposition would authorize the District to levy the following excess taxes, to replace an expiring levy to support the District's educational programs and operations which are not funded or not fully funded by the State:
